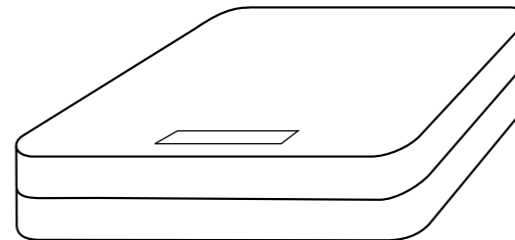

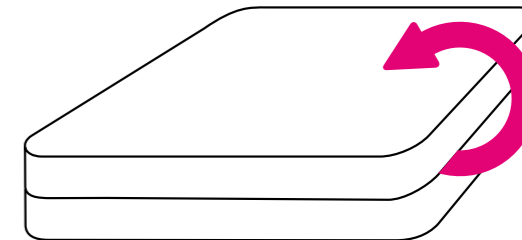

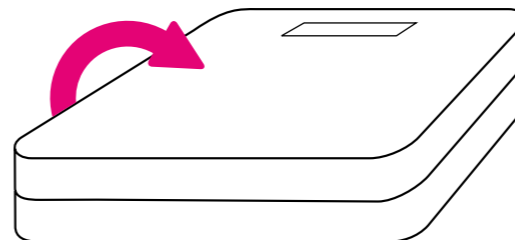
LABEL FACE UP AT FOOT.

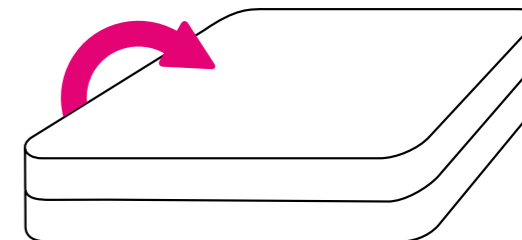
LABEL FACE DOWN AT FOOT.
